Welcome to the 2023 tax filing season. It is our hope that the year 2023 was good to you and your family.

We wanted to share an exciting announcement that we will be transitioning our business to new owners during this tax season. After an extensive search, we feel we have found two individuals that can best continue the excellent service that you deserve. We will be working during tax season to ensure a successful transition and will introduce you to the new owners, Geri DeFrancisco and Teddy Sullivan of Human Tax Partners. It is our intent that the transition will be smooth and your tax planning and tax preparation will continue as usual. We will continue to be a resource to you through Human Tax Partners in the future as we ease into retirement.

We will continue to use our portal, Liscio, which offers secure submission for your sensitive documents. In addition, all correspondence through Liscio will be stored here securely. Thank you to the many of you who have set up your Liscio account and are active users. We strongly encourage anyone who has not, to setup their Liscio account this year. Our office can send you an invite to set up your account. We will no longer send sensitive information, including copies of tax returns, via unsecure email. Final tax returns will be sent through Liscio with paper copies available upon request. We will still be accepting tax information dropped off during office hours and through the mail.

Payment for your tax return will be collected before submission. Human Tax Partners will accept credit card, ACH payments, cash, or check. Due to increasing costs, there will be a modest increase in fees.

The IRS has been working diligently to catch-up on processing paper returns including some from 2021 and 2022. Those of you that have had to file a paper return should be receiving your Information Protection PIN (IP PIN) in the mail in January. If you have an IRS account you will be able to access the IP PIN through your account. While in your account you can click on the help section and type GET IP PIN in the search box. If anyone is interested in obtaining an IRS account, you may access the process on www.irs.gov and click on Sign into My Account. You will be able to create an account.

The IRS has already indicated that returns with refundable credits such as Child Credits, Tuition Credits and Earned Income Credits may be delayed until March. With that in mind, we are encouraging clients to submit their 2023 information to us as soon as possible, so we can complete the return and get you in the queue. However, congress is still considering changes to two major tax provisions the child credit and bonus depreciation that if enacted my further delay filing.

The IRS has expanded the residential energy credits. You should provide us with the cost of your energy improvements, such as new exterior doors and windows and energy efficient heating and cooling systems.

As a reminder, New Jersey added some deductions beginning with the 2022 tax return. There is now a deduction of up to \$10,000 for contributions to a NJ Best 529 plan. There is also a deduction of up to \$2,500 of student loan interest on student loans through NJ Class loans and an up to \$10,000 tuition deduction for in state tuition for taxpayers and dependents. The three new deductions/credits above are for incomes less than \$200,000. NJ is also providing a Child Tax Credit of \$100-\$500 on a sliding scale for incomes less than \$80,000.

Attached is a checklist, which may assist you in compiling your 2023 tax information. A personalized checklist has been emailed to you if you have previously provided us with your email address. If you have not received the checklist, please call the office and provide your email address.

We would appreciate it if you do not include receipts with your tax information. A summary of the deductible expenses should be provided. You can also enter the totals on your checklist or your drop off questionnaire.

Contact us early to secure your preferred appointment time and we will be available to discuss the items included in this letter as well as any others you may have. When you drop-off your information, it is important that you have completely **filled out the enclosed Drop-off Questionnaire**. We appreciate your business and are looking forward to working with you.

Our deadline for submission of information to guarantee completion of your returns by the April 15, 2024 deadline will be March 22, 2024. For those planning to go on extension, April 6th will be the deadline to guarantee your information will be input to create a compliant extension.
